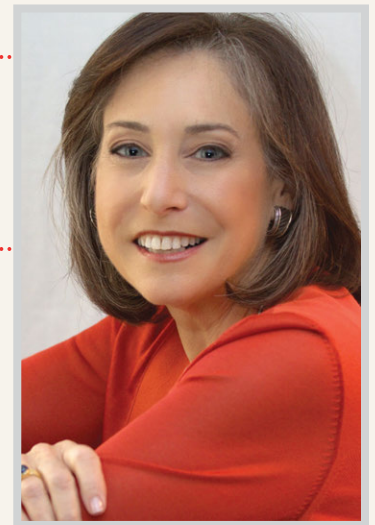


*Lady at the O.K. Corral* is the biography of Josephine Marcus Earp, the woman who was Wyatt Earp's common law wife for nearly 50 years...

### Five Days at Memorial: Life and Death In A Storm-Ravaged Hospital

*In Five Days at Memorial: Life and Death in A Storm-Ravaged Hospital*, physician and reporter Sheri Fink reconstructs five days at Memorial Medical Center and draws the reader into the lives of the doctors and nurses who struggled to preserve life amidst chaos. After Katrina destroyed the generators that make twenty-first century medicine possible, to be a patient at Memorial meant you were wholly at the mercy of caregivers forced to make a life and death decisions in the face of serious illness and limited medical care. The result was an almost unthinkable tragedy: several health professionals deliberately injected severely ill patients with drugs to hasten their deaths.

An engrossing narrative that exposes the human drama that fuels medicine and the uncharted territory of end-of-life care. Fink brings the reader into a hospital fighting for its survival and into a conversation about just how ill-prepared we are as Americans for the impact of large-scale disasters on the most vulnerable among us.
